Together, they merge to create an innovative and respected organization that remains committed to providing quality post-acute care, meeting the needs of our communities and striving for continuous improvement.

This past fiscal year, Good Shepherd advanced its health-care reform strategy. Our Board of Trustees and senior leaders worked on planning and growth that align with health-care reform's current and future requirements, which focus on the delivery of high-quality care in a cost-effective manner. We worked on strengthening existing partnerships, engaging potential collaborators and planning for new opportunities that will enhance our patient outcomes.

Our hard-working staff was dedicated this past year to implementing processes and systems that assured Good Shepherd's status as a leading rehabilitation care provider and employer. We focused on improving patient satisfaction, safety and outcomes. New software systems were installed for budgeting, event reporting and human resource management. Our clinical documentation system was extended to Good Shepherd Rehabilitation at Pocono Medical Center and to our Physician Group. Telemedicine was piloted at Good Shepherd Rehabilitation Hospital in Allentown, and Good Shepherd's long-term care homes added the Pyxis medication system and a wound care program.

These all were continuous improvement initiatives guided by Good Shepherd's mission and core values (see below). Good Shepherd's staff also aligns its work with Pillars of Excellence: People, Quality, Service, Finance and Growth. Focusing on excellence in these five areas allowed Good Shepherd to end fiscal year 2011 with a solid financial performance. Good Shepherd's hard-working team overcame financial challenges in the first six months of the year to achieve a consolidated, positive operating margin (combined with Good Shepherd Penn Partners) of 6.2 percent, or \$8.0 million.

Good Shepherd's Board of Trustees, staff, donors and volunteers all deserve to be acknowledged for making fiscal year 2011 a successful one. A special thank you goes to our patients, residents and their family members, who entrust us with one of life's most precious things — their health.

We hope you will spend some time reading this 2011 Report to the Community, which highlights the people and technology that continue to move forward the vision we share for this 103-year-old organization. Thank you for your continued support of Good Shepherd Rehabilitation Network.

# **POSITIVE STRIDES**

### More Beds for More Patients

Is Good Shepherd starting to see the impact of the aging population on inpatient rehabilitation? Good Shepherd Rehabilitation Hospital–Allentown experienced a **25 percent census growth** in the second half of fiscal year 2011. This resulted in 4 additional beds being added to the unit, for a total of 74 beds.

Receiving care at a Good Shepherd inpatient rehabilitation unit is different than at an acute-care hospital or nursing home. At the Rehabilitation Hospital, Good Shepherd's physicians, nurses and therapists (physical, occupational, speech and recreational) work in specialized teams for orthopedic, brain injury, spinal cord injury, stroke and other neurological conditions. Patients receive up to three or more hours of therapy each day. This **Good Shepherd "difference"** results in the highest level of inpatient rehabilitation outcomes.

### Walking Tall with eLEGS

Kevin Oldt did not remember how tall he was until he stood for the first time in nine years. Oldt, who had a snowmobiling accident, stood up, bent his knees and walked with **eLEGS**, a wearable, robotic exoskeleton. He was one of seven people with lower-extremity paralysis who participated in an eLEGS's investigational trial last May at Good Shepherd's Outpatient Neurorehabilitation Program.

Named by *Time* Magazine as **one of the 50 best inventions in 2010**, the battery-powered eLEGS was developed by Berkeley Bionics to power up wheelchair users with lower-extremity paralysis. A computer in the eLEGS system commands motors in the hip and knee joint to move the legs through a smooth, natural gait. In early 2012, Good Shepherd will become one of the first rehabilitation hospitals in the country to acquire an eLEGS system for inpatient and outpatient therapy. Oldt definitely will be first in line for the therapy sessions, and Good Shepherd will continue to be a leader in testing and utilizing rehabilitation technology.

# PEDIATRICS: A SUCCESS STORY

### **Pediatric Unit: A National Destination**



There have been many heart-tugging stories about children who have been helped at the 16-bed Good Shepherd Rehabilitation Hospital Pediatric Unit since it opened in 2009. This past fiscal year, the Pediatric Unit itself was a success story, **beating census well in advance of a four-year projection** and having a waiting list on many days.

The Pediatric Unit and its staff have earned a regional and national reputation for excellent outcomes, compassionate care and unique services. As **one of the only programs in the country for infants with feeding disorders,** the Pediatric Unit's Neonatal and Infant Feeding Program offers SOS (sequential oral sensory) and Beckman Oral Motor techniques. Parents from as far away as Montana have brought their babies to Bethlehem for these services.

### Dornsife Outpatient Pediatric Care at Capacity

It was the first full year of operation for the **Dornsife Pediatric Therapy Suite.** The suite houses the outpatient feeding program and 13 speech language pathologists who treat children with a variety of diagnoses, from developmental delays to traumatic brain injury. Both outpatient areas in our Health & Technology Center in Allentown are operating at capacity as we try to meet the demands for specialized physical and cognitive rehabilitation for the children in our area. Last year, **more than 4,500 children received inpatient, outpatient and physician care,** which is a more than 35 percent increase in the past two years.





# CHOP Center for Rehabilitation

Under the leadership of Good Shepherd's chief medical officer, Phillip Bryant, DO, and vice president of pediatrics, Brent Reitz, MBA, FACHE, Good Shepherd fulfilled its CHOP management contract deliverables for last fiscal year. Good Shepherd (which manages CHOP's rehabilitation services) helped restructure the medical staff to create a Division of Rehabilitation. A new physician staffing model was designed, a new director was hired to oversee the operations of the center, new referral relationships were cultivated and strategic planning was conducted. Good Shepherd and CHOP continue to work together to enhance post-acute care services at the Philadelphiabased health-care organization.

# STRIVING FOR EXCELLENCE

### **Re-Engineering Systems**

Continuous improvement was an important part of the work performed by our staff last fiscal year. To assure Good Shepherd's status as a leading rehabilitation care provider and employer, many **technological processes and systems were implemented,** including:

- Telemedicine was piloted at the Good Shepherd Rehabilitation
   Hospital-Allentown and will be utilized starting September 2011
   in cooperation with Lehigh Valley Health Network. (Telemedicine
   services already exist at the Good Shepherd Specialty Hospital.)
- The Mediserve Clinical Documentation System was expanded to Good Shepherd Rehabilitation at Pocono Medical Center and for use by the Good Shepherd Physician Group.
- Pyxis, a medication safety system, was added to the long-term care facilities. The system is in place in all inpatient units.
- Eclipsys, a software system, makes the budgeting process simpler.
- rL Solutions Event Reporting System supports consistent documentation of patient and employee safety issues.
- StaffNet/UltiPro is a human resources information system that allows employees real-time access to benefit and payroll information.

### **Employee Commitment**

Measured during an annual employee climate survey, Good Shepherd's fiscal year 2011 **employee commitment score rose to the 65th percentile.** The commitment score, which combines employee satisfaction, pride and loyalty, is one way of measuring overall employee opinions about the workplace, and it typically impacts outcomes like patient satisfaction and productivity.



### Focus on Strategic Goals

Good Shepherd's leaders focus on strategic goals to maintain outstanding patient care while ensuring the organization's future viability. Planning and meaningful growth are important for any organization, but **strategic flexibility is now vital** due to the current and anticipated changes associated with health-care reform.

### Good Shepherd's Strategic Directions

- Create a continuum of care that integrates acute and post-acute care
- Develop service line centers of excellence in Neurorehabilitation, Musculoskeletal/Orthopedic Rehabilitation, Pediatric Rehabilitation and Cardiopulmonary/Complex Medical Care
- Grow in new markets by identifying the "right partners"
- Develop new management contracts and health system partnerships
- Continue to explore the development of a continuing care hospital, which may include inpatient rehabilitation, long-term acute care and skilled nursing care, in the Lehigh Valley

# PARTNERSHIPS FORGE FUTURE

Never in the history of health care have partnerships been more important. Good Shepherd excels at partnering with organizations that match its mission and values. Those partnerships range from coordinated services for MS patients with Lehigh Valley Health Network to being owners of a post-acute care organization with nationally acclaimed health system Penn Medicine.



In preparing for changes to health-care delivery and payment, Good Shepherd worked last fiscal year to position itself as a post-acute care partner with regional health-care networks. Good Shepherd's staff is working on a pilot project with regional hospitals for stroke episodeof-care planning. The goal for episode-of-care coordination is not only to ensure a smooth transition for patients between facilities, but also to enhance the quality of care while reducing costs and re-admissions to acute-care hospitals.





### A World-Class Partnership

Good Shepherd Rehabilitation Network and Penn Medicine came together in 2008 to open Good Shepherd Penn Partners (GSPP), which provides the Philadelphia region with a continuum of post-acute care that includes inpatient and outpatient rehabilitation and long-term acute care.

Penn Medicine saw in Good Shepherd a partner with post-acute care management expertise and outstanding outcomes. Good Shepherd, as majority owner of GSPP, has added two Penn Medicine physical medicine and rehabilitation residents in the Lehigh Valley and will benefit from Penn Medicine's research and education.

Last fiscal year, GSPP continued its financial success and paid its first dividend to the two partner organizations — a year ahead of schedule.

GSPP continued to grow last fiscal year, with a new outpatient site opening in Yardley, Pennsylvania, and the Westhampton, New Jersey, outpatient site relocating to Woodbury Heights, New Jersey. In addition, GSPP committed \$3.4 million for renovations to the first floor of Penn Medicine at Rittenhouse for a new 12,000-square-foot Good Shepherd Penn Partners Penn Therapy & Fitness site, which will specialize in neurorehabilitation and musculoskeletal/orthopedic rehabilitation. The site is scheduled to open in November 2011.


### Number of Employees




