A FAMILY ENDOWMENT PROGRAM

When Dick and Peggy Fleming gave a major gift to establish the Fleming Family Endowment Program for Assistive Technology and Research at Good Shepherd, they wanted to make it possible for other families to make endowment gifts if they so desired. Knowing that named endowments typically require a substantial contribution that most families cannot afford, the Flemings set up this endowment program with the purpose of offering families an opportunity to participate in named endowment giving with more modest but no less meaningful contributions. "Such a gift is truly a living memorial," says Dick Fleming. The endowments will provide perpetual support for Good Shepherd as a center of excellence in its development and use of assistive and rehabilitation technology. These technologies help people with disabilities communicate better, have more control



over their daily lives and enjoy greater mobility. Clinical research in neurorehabilitation technology is a key contributing factor in Good Shepherd's mission. In addition to fostering innovative ideas and a clear understanding of underlying processes, such research may lead to more practical and effective assistive and rehabilitation technologies in the home and community. This, in turn, can lead to better clinical outcomes and an improved quality of life for a variety of people, ranging from the frail elderly to those with significant medical conditions, such as multiple sclerosis, spinal cord injury, traumatic brain injury and stroke. "When people with disabilities can assert their independence and draw sustenance from that, they become happier, more productive members of the community," says Fleming. "And by doing so, they provide an example from which all of us can benefit."

A FRIEND IN NEED AND A FRIEND IN DEED

One of Good Shepherd's most steadfast supporters is 2001 Raker Memorial Award recipient Robert Girling. For nearly 20 years, Girling has supported and participated in the annual Celebrity Golf and Tennis Classic, which benefits Good Shepherd's Pediatrics Program. He has supported the event in many ways, including serving as chairman in 1992 and stepping



forward again as a platinum sponsor in 2007, just as he's done many times over the years. Girling's generosity has also brought many notable celebrities to the Celebrity Classic, including the late legendary golfer Sam Snead. Girling's dedication to this event is just one example of his charitable nature. Years ago, after a tour of Good Shepherd's facilities, he was especially impressed with the care given to Good Shepherd's residents. That visit prompted him to extend his philanthropy to programs, services and equipment benefiting them. One gift was given with the hope that it would make Thanksgiving dinner extra special for the residents. It certainly did when Good Shepherd invited the Singing Boys of Pennsylvania to perform. The Girling Foundation, established by Bob Girling, has chosen Good Shepherd as one of its preferred charities.
